## **ACARIX PUBLISH SUPPLEMENT TO PROSPECTUS**

**Acarix AB ("Acarix" or the "Company") has prepared a supplement to the prospectus relating to the invitation to subscribe for units with preferential rights in the Company (the "Rights Issue") which was approved by the Swedish Financial Supervisory Authority (Sw. Finansinspektionen) ("SFSA") on 14 December 2022 and published by the Company the same day (the "Prospectus"). The supplement to the Prospectus has been prepared due to the fact that the Company has received an additional guarantee commitment in the Rights Issue consisting of a so called top guarantee of SEK 1 million, which was announced by the Company through a press release on 21 December 2022. The supplement prospectus has today been approved by the SFSA and published on the Company's website.**

The supplement prospectus has been prepared in accordance with Article 23 of Regulation (EU) 2017/1129 of the European Parliament and of the Council of 14 June 2017 on the prospectus to be published when securities are offered to the public or admitted to trading on a regulated market (the "**Prospectus Regulation**"). The supplement prospectus was approved by the SFSA on 22 December 2022. The supplement prospectus is part of the Prospectus and must be read together with the Prospectus. The Prospectus and supplement prospectus are available on the Company's website <https://www.acarix.com/for-investors/rights-issue-2022> and will in a few days also be available on the SFSA's website (<https://fi.se/sv/vara-register/prospektregistret/>).

Investors who, prior to the publication of the supplement prospectus, have applied for or otherwise consented to subscription of units in the Rights Issue have, in accordance with Article 23 of the Prospectus Regulation, the right to withdraw their application or consent within three working days after the publication of the supplementary prospectus, i.e., up to and including 28 December 2022.
